RESOLUTION NO: 08-2026

A RESOLUTION APPOINTING LYLE GRANDY AS THE DIRECTOR OF EMERGENCY MANAGEMENT PURSUANT TO K.S.A. CHAPTER 48 AND K.A.R. 56-2-2

WHEREAS, K.S.A. 19-101 et seq. and K.S.A. 19-212 authorize the Board of County Commissioners to transact all county business and perform all powers of local legislation deemed appropriate and necessary for the governance and protection of the county; and

WHEREAS, K.S.A. Chapter 48 (the Kansas Emergency Management Act) authorizes counties to establish and maintain local emergency management organizations and to designate or appoint officials to carry out emergency preparedness, response, recovery, and mitigation duties;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
CHEROKEE COUNTY, KANSAS, THAT:**

1. Lyle Grandy is hereby appointed and designated to assume and perform the duties and responsibilities of the Director of Emergency Management for Cherokee County beginning March 30th, 2026.
2. Lyle Grandy shall have all powers, duties, and responsibilities assigned to the Director of Emergency Management under state law, administrative regulations, county resolutions, emergency operations plans, and applicable mutual aid agreements.
3. This appointment shall remain in effect until such time as the Board of County Commissioners rescinds this resolution or appoints another individual to serve as Director of Emergency Management in accordance with Kansas law.
4. Lyle Grandy shall coordinate with state and local emergency management agencies, municipal governments, fire districts, emergency medical services, and other relevant entities to ensure continuity of emergency preparedness and response operations.

BE IT FURTHER RESOLVED, that this resolution shall be published once in the official county newspaper and shall be in full force and effect from and after its date of publication.
