The Cherokee County Commissioners met November 26, 2012. Those present were Commissioners Pat Collins, and Jack Garner. The Pledge of Allegiance was said by all present. Commissioner Collins made a motion to approve the commission minutes for November 19, 2012 as presented by County Clerk Crystal Gatewood; his motion was seconded by Commissioner Garner with Commissioners Garner and Collins voting in favor. Commissioners Garner and Collins, and Deputy Paula Cheney signed off on the minutes.

MOTIONS MADE BY COMMISSION

Commissioner Collins made a motion to pass the 2013 Accounts Payable/Payroll/Holiday Schedule; his motion was seconded by Commissioner Garner with Commissioners Garner and Collins voting in favor.

EXECUTIVE SESSIONS

Commissioner Collins requested an Executive Session. Then went in at 11:30 AM and returned at 11:37 AM.

OTHER BUSINESS


Leonard Vanatta of the Road and Bridge Department brought in a contract with the BNSF Railroad for work on the crossing at three miles south of Scammon and east of Highway 7, to install signal lights. Commissioner Garner and Deputy Paula Cheney signed off on the documentation. The commission and Leonard discussed other railroad crossings in the county. Mr. Vanatta reported the bridge replacement at 50th and SE Quaker Rd is hopefully going to get started in late 2013. A new bridge at 120th and Belleview should be getting started today.

Counselor Cure discussed the upcoming tax sale for 2013. He also brought in a Lease Property Agreement for the Pattons with Commissioners Garner and Collins, and County Clerk Gatewood and Counselor Cure signed off on the agreement.


