MINUTES FOR MAY 6th, 2013

BOARD OF CHEROKEE COUNTY COMMISSIONERS

CHEROKEE COUNTY, KANSAS

CONVENE

Chairman Richard Hilderbrand called the regular session of the Cherokee County Board of Commissioners to order and led all in attendance in the Pledge of Allegiance at 9:00 AM on Monday, May 6th, 2013 in the Commission Room, #109 of the Cherokee County Courthouse. Commissioners Pat Collins, Charles Napier, Richard Hilderbrand, and County Clerk Rodney Edmondson were present.

Members of the press present: Larry Hiatt, Patrick Richardson, and Machelle Smith

Visitors Present: Jerry Messer, Breana Mogle

Leonard Vanatta - County Road Supervisor Gene Langerot - County Lot Supervisor

They appeared before the Board on routine county business. They informed the Board that asphalting will begin tomorrow on the road to Claythorne Lodge. No further action was taken.

A motion was made by Commissioner Napier to donate \$3,000 to All God's Creatures for their Animal Rescue Program. The motion was second by Commissioner Collins. The motion carried 2-1 with Commissioner Hilderbrand voting no for the reason of not knowing where the funds will be taken from.

A motion was made by Commissioner Napier to donate \$2,000 to the Columbus Public Library. The motion was second by Commissioner Collins. The motion carried 2-1 with Commissioner Hilderbrand voting no for the reasons of it being a city library that receives city taxes, and the location where the funds will be taken.

Raymond Griffitt - Citizen

He appeared before the Board to voice his concerns over a land dispute. The Board took his concerns under advisement.

Department Heads - Monthly Reports

Barbara Bilke, Register of Deeds - provided a written report of her office activity.

Betha Elliott, Health Dept. - provided an update on the improvement projects at the Health Dept. The vacant lot located next to the Health Dept is for sale. She would like the Board to consider purchasing the property. They used to lease it for parking years ago. They use it from time to time to park vehicles for special events. If the property sells to someone else, there will be very limited parking for employees and clients of the Health Dept. She has funds to purchase the property. The Board took her offer under advisement.



David Groves, Sheriff - He reported that the prescription drug take back program has netted 234 pounds of prescription pills this year. They have collected over 1,000 pounds since they started the program. A total of 145 concealed carry permits have been issued since January 2013.

The Sheriff's Department and the Kansas Highway Patrol will be conducting a DUI Checkpoint east of Baxter this weekend. They are pursuing another COPS Grant for school resource officers. He should know the results of the grant application in September.

Deana Randall, H.R. - Cutoff dates for May are on the 8th, and the 15th at noon.

Jason Allison, Emergency Preparedness - updated the Board on activities in his office.

Juanita Hodgson, Treasurer - Second half taxes are due this Friday. She updated the Board on the AS400 Computer System. The current system is 6 years old. IBM recommends an upgrade. She presented cost estimates in writing to the Board of approximately \$23,000. The Board took it under advisement.

Nancy Herrenbruck, Appraiser - Her office has finished informal hearings. The 30 day appeal time period is over. They are getting ready to certify to the Clerk's office by June 15th. They will begin the 17% appraisals soon.

Nathan Coleman, Attorney - Nothing new to report

Ralph Houser, Courthouse Maintenance - Nothing new to report

Rodney Edmondson, Clerk - provided dates for the upcoming USD 499 Bond Election that will be held on June 4th, 2013 in Galena. He reported that he and Paula will be attending a training conference Tuesday through Friday this week in Manhattan.

Cecil Brown, Noxious Weeds - Presented a state report for signatures from the Board. Chairman Hilderbrand signed the report.

Wayne Elliott, 911/Mapping - He reported that his office issued two new addresses last month.

Leonard Vanatta, Road & Bridge - nothing new to report.

Trish Carroll, Joe Schibi - Columbus Telephone Co.

They presented a proposal based on a technical analysis done by them and an audit performed by Allied Business Solutions to streamline and make more cost effective the phone system in the Courthouse. It is flexible and could include the Health Department and the County Lot with an additional cost for equipment and hardware. The Sheriff's Office already has an updated system. The proposed system has a purchase price of \$38,984 that provides annual savings of \$8,352 with a ROI of less than 4 ½ years. They will provide training for each department with the switchover occurring on a weekend so service would not be interrupted. The Board asked them to do a proposal that would include adding the other two departments, and present it to the Board next Monday, May 13th at 10:00 AM.

Ralph Houser - Courthouse Maintenance

11:00 AM - Opening of the bids for the Courthouse windows. Home Pro is the only bid submitted. Total cost of the proposal is \$136,854 for 145 vinyl windows and installation.



A motion was made by Commissioner Collins to accept the bid from Home Pro to install 145 new windows in the Courthouse at a cost of \$136,854. The motion was second by Commissioner Napier. The motion carried 3-0 with all voting yes. The funds are to be taken from County Courthouse Funds. The down payment of 50% will be paid when a copy of their bond is received by the County Clerk.

Jack Johnson - Citizen & Business Owner

He appeared before the Board to voice his concerns over the taxes on property he wants to purchase. The land value has increased drastically in recent years without any improvements to the property, including a 512% increase from 2008 to 2009. Nancy Herrenbruck, County Appraiser, offered her explanation for the values. She will look into it further and get back with him later today.

Larry Sharp - KCAMP

He appeared before the Board to provide a quick review of county property and liability insurance coverage. In the insurance industry over the past 3 years the casualty claims have been abnormally high and have resulted in a large increase in residential property homeowners premiums. KCAMP has seen the same results.

The risk avoidance grant of \$2,000 was not used last year by Cherokee County. Its purpose is to be used to reduce or eliminate areas of risk or liability. The chairman was given an application. The grant is mostly used for replacement of the tarps for dump trucks. Law Enforcement often uses it for push bumpers on patrol cars.

KCAMP also has an online university available to be used for training purposes. 15 hours are available for Law Enforcement use toward their annual continuing education hours.

The Board took his recommendations under advisement.

Kevin Cure - County Counselor

A motion was made by Commissioner Collins to approve completing an application for exemption of the road recently deeded from Gary McCorkle to Cherokee County in the Gilstrap Addition. The motion was seconded by Commissioner Hilderbrand. The motion carried 3-0 with all voting yes.

Kevin updated the Board on other County legal matters. No action taken.

A motion was made by Commissioner Collins to recess for lunch. The motion was second by Commissioner Hilderbrand. The motion carried 3-0 with all voting yes at 12:11 PM.

The meeting reconvened at 1:05 PM.

A motion was made by Commissioner Collins to amend the agenda from 1:15 PM to 1:07 PM for Jean Pritchett and the Tourism Grant Application. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Jean Pritchett - Tourism Grant Application

She appeared before the Board to present a Cherokee County Tourism Grant Application from the Galena Volunteer Fire Department in the amount of \$300 for the Galena Days Celebration on May 30th, 31st, and June 1st, 2013.



A motion was made by Commissioner Napier to approve the grant application for the Galena Volunteer Fire Department in the amount of \$300. The motion was second by Commissioner Collins. The motion carried 3-0 with all voting yes.

A motion was made by Commissioner Collins to approve the Minutes of the April 29th, 2013 Commission Meeting as written. The motion was seconded by Commissioner Napier. The motion carried 3-0 with all voting yes.

Myra Frazier - Carlisle Real Estate

She appeared before the Board to present a contract to purchase on the NSP Grant property located at 402 E 5th St. in Galena. After consulting with County Counselor Kevin Cure and Susan Galemore from the SEKRPC, it was determined that the contract would need to be rewritten. The Board asked her to have it redone and submit it to them next Monday. She was placed on the agenda for May 13th, 2013 at 1:00 PM.

A motion was made by Commissioner Collins for an Executive Session for a period of 10 minutes with Emergency Preparedness Director Jason Allison for the purpose of Non/Elected Personnel. The motion was second by Commissioner Napier. The motion carried 3-0 with all voting yes at 1:31 PM.

The meeting reconvened at 1:41 PM.

No action was taken as a result of the Executive Session.

A motion was made by Commissioner Napier to enter into a contract to purchase the vacant property next to the Health Department, pending an environmental survey, at a cost of approximately \$13,000. The motion was seconded by Commissioner Collins. The motion carried 3-0 with all voting yes. The property will be purchased by funds from the Health Department.

Commissioner Collins made a motion to adjourn until the next regularly scheduled meeting set for May 13th, 2013 at 9:00 AM. The motion was second by Commissioner Napier. The motion carried 3-0 with all voting yes at 1:54 PM.



Dear Cherokee County Commissioners:

Columbus Telephone Company established in 1905 has been serving the communications needs of the Cherokee County Court House for many years. As a local communications provider, there are many benefits for Cherokee County to utilize the services of Columbus Telephone.

- 1. Columbus Telephone is a cooperative who returns capital credits to each member of the cooperative. Historically the county has received refunds each year equivalent to approximately 35-40% of the monthly recurring charges and long distance service.
- Columbus Telephone Company has an experienced staff that is available to respond to service or hardware needs typically the same day.
- 3. Columbus Telephone Company Internet service is fully redundant with two providers in the event one provider connection would not be operational.
- Columbus Telephone Company technical staff is experienced with installation, service and training on NEC telephone systems. We have recently installed systems in two major Columbus businesses.
- 5. Columbus Telephone Company can offer a volume business plan for long distance service which is rated at \$0.041 cents per minute billed in 6 second increments and billed a \$5.95 charge per department regardless of the number of lines.
- 6. Cable television service can be consolidated for the following departments Attorney: account number 2803; District Court: account number 2849; Janitor/Maint: account number 0831 however Law Enforcement: account number 2963 and Health Dept.: account number 2060 is not located within the court house and therefore is classified as an additional location where standard cable television package rates would apply. Any office or department with a coax outlet would have the ability to connect without a set top box and they would receive the 13 basic channels in our lineup for no additional cost.
- 7. Columbus Telephone would propose to consolidate Internet access within the court house to activate one 24Mb connection with a wireless access point and dependent upon each departments Internet access requirements could connect to one

- password protected router. The court house IT department should be included in this decision to verify all departments' security and bandwidth requirements are met.
- 8. Columbus Telephone Company has worked with Allied Business Solutions to consolidate and identify areas of savings where telephone lines were not being utilized by departments.

Finally, the NEC telephone system proposed will create much efficiency for the departments as well as streamline the experience for taxpayers or others calling the court house.
