MINUTES FOR MAY 9, 2011

COLUMBUS, KANSAS, CHEROKEE COUNTY

OFFICE OF THE COUNTY CLERK

The Cherokee County Commissioners met May 9, 2011. Commissioners Collins, Garner, and Hilderbrand were present. The Pledge of Allegiance was said by all present. Commissioner Hilderband made a motion to approve the minutes for May 2, 2011 as submitted by Cherokee County Clerk Crystal Gatewood; his motion was seconded by Commissioner Garner with Commissioners Hilderbrand and Garner voting in favor. Commissioners Hilderbrand, Collins, and Garner, and County Clerk Gatewood signed off on the minutes. Commissioner Collins abstained from the motion and vote due to his absence at the May 2, 2011 meeting.

MOTIONS MADE BY COMMISSION

Commissioner Hilderbrand made a motion to amend the minutes on April 25, 2011, an inserting in the motion appointing Dana Lynch to the JCAB Committee; his motion was seconded by Commissioner Collins with Commissioners Collins, Hilderbrand, and Garner voting in favor.

Commissioner Hilderbrand made a motion to approve the May Mid-Month 2011 Accounts Payables; his motion was seconded by Commissioner Collins with Commissioners Collins, Hilderbrand, and Garner voting in favor. Commissioners Collins, Garner, and Hilderbrand, and County Clerk Crystal Gatewood signed off on the Accounts Payables. County Counselor Kevin Cure was not present, therefore did not sign off.

Commissioner Collins made a motion to appoint Lee Howard as Trustee for Lowell Township; his motion was seconded by Commissioner Hilderbrand with Commissioners Collins, Garner, and Hilderbrand voting in favor.

Commissioner Garner made a motion to place an ad in the Big Nickel and Joplin Globe for the Tax Sale, and put the entire listing of properties for the Tax Sale in the News Report, Baxter Springs, and Galena Sentinel newspapers for the public; his motion was seconded by Commissioner Collins with Commissioners Collins, Garner, and Hilderbrand voting in favor.

EXECUTIVE SESSIONS

Commissioner Collins made a motion to go into Executive Session for Personnel/Non-Elected for ten minutes with himself, Commissioners Garner and Hilderbrand, Leonard Vanatta, and Gene Langerot; his motion was seconded by Commissioner Garner with Commissioners Garner, Hilderbrand, and Collins voting in favor. They went in at 9:34 AM and returned at 9:44 AM.

Commissioner Garner made a motion to go into Executive Session for Personnel/Non Elected for three minutes with himself, Commissioners Hilderbrand and Collins, and County Attorney John Bullard; his motion was seconded by Commissioner Collins with Commissioners Hilderbrand, Collins, and Garner voting in favor. They went in at 11:06 AM and returned at 11:10 AM.

OTHER BUSINESS

Leonard Vanatta, Road and Bridge Supervisor, and Gene Langerot of the County Lot discussed general county and road maintenance was being done by his department. The commission agreed to pay \$350.00 out of the Road & Bridge Department for the annual dues for KAC.

County Counselor Kevin Cure and the commission discussed the upcoming County Tax Sale scheduled for June 9, 2011.

Treasurer Juanita Hodgson and the commission discussed the purchase of computer equipment for the county server and the commission directed her to get more information involving the purchase. The current server is five years old and in need of an upgrade and various ideas were discussed. The anti-virus renewal for the county was discussed and no decisions were made by the commission. (Attached to the minutes is the quote for the Anti-virus program).

Wayne Elliott of 911 Mapping came before the commission to discuss the purchase of refurbished computers for his office. The commission asked him to get a quote for new mother boards and get back with them with the information.

Betty McBride of the Treece Buyout Committee for the State of Kansas came before the commission to have three properties in Treece taken off the Tax Sale. The commission said they would refer it over to County Counselor Kevin Cure and they agreed to remove the properties from the sale.

Mark Lawler of Clean Line Energy Partners came before the commissioners to discuss and present the company's proposal for delivering wind energy power created in Kansas through HVDC transmission lines to population centers outside of Kansas. The commission expressed concern of the lines and tax revenues were an issue because the lines would be abated for ten years. Commissioner Garner expressed concern over the lines going through Cherokee County and the citizens not benefitting from the transfer of power and seeing a cheaper power source for electricity. They thanked him for coming in. (Attached to the minutes is a copy of his proposal).

Commissioner Collins made a motion to adjourn the meeting at 12:08 PM; his motion was seconded by Commissioner Hilderbrand with Commissioners Hilderbrand, Garner, and Collins voting in favor. 



HVDC brings economic, policy and electric reliability benefits

More efficient– Over long distances, DC transfers more power with lower line loss than comparable AC lines.


Smaller footprint – DC requires a narrower right of way (ROW) than an equivalent AC configuration.

Lower cost– Less infrastructure and lower line loss means lower cost and lower price for renewable power.

Improved reliability – Gives operator complete control over power flow.

Merchant model– Clean Line will fund the development costs of the transmission projects and will sell transmission capacity to wind generators and/or purchasers.

Three 500 kV lines 600 foot ROW




One ± 500 kV bipole 150-200 foot ROW





- Responded to DOE 1222 RFP in 2010


