

MINUTES for December 20, 2024
BOARD of CHEROKEE COUNTY COMMISSIONERS'
CHEROKEE COUNTY, KANSAS

CONVENE

Chair Cory Moates called the regular session of the Cherokee County Board of Commissioners (the Board), to order at 8:00 AM on Friday, December 20, 2024, in the Commission Room, #109 of the Cherokee County Courthouse located at 110 W Maple St., Columbus, Kansas. County Commissioner Myra Frazier opened the meeting with prayer followed by the Pledge of Allegiance. Commissioners Cory Moates, Lorie Johnson, Myra Frazier, County Clerk employee Michelle Mosler, County Counselor Jake Conard, and Roger Draeger were present.

PAYROLL

Commissioner Moates motioned to approve the payroll as presented. Commissioner Johnson seconded the motion. The motion passed unanimously.

ACCOUNTS PAYABLE

Commissioner Frazier motioned to approve the accounts payable as presented. Commissioner Johnson seconded the motion. The motion passed unanimously.

INTERAGENCY AGREEMENT

Commissioner Moates motioned to approve the ARPA interagency agreement with Economic Development in the amount of \$200,000 for the planning commission/zoning and to authorize Dale Helwig to sign it. Commissioner Johnson seconded the motion. The motion passed with Commissioner Frazier opposing it.

ACCOUNTS PAYABLE

Commissioner Frazier motioned to approve the accounts payable as presented. Commissioner Johnson seconded the motion. The motion passed unanimously.

CEREAL MALT BEVERAGE

The approval was tabled until the December 30th meeting. Will wait on background check to come back.

EMERGENCY MANAGEMENT

Commissioner Moates motioned to approve the Blue Valley contract for storm sirens with ARPA funds. Commissioner Frazier seconded the motion. The motion passed unanimously.

MAINTENANCE

Commissioner Johnson motioned to approve the purchase of 2 Cub Cadet push mowers, plumbing snake, battery jump box, a 16X10 carport, 2 round tables (46 inches), and 6 gallons of paint for fountain for a total of \$6085 using ARPA funds. Commissioner Frazier seconded the motion. The motion passed unanimously.

ROAD AND BRIDGE

Commissioner Frazier motioned to approve the purchase of tires and cutting edges for \$16267.60 using ARPA funds. Commissioner Moates seconded the motion. The motion passed unanimously.


SOLAR


Roger Draeger notified the commissioners that One Energy will be attending the next meeting, December 30th, to discuss solar energy.
