The Cherokee County Commissioners met May 16, 2011. Commissioners Collins, Garner, and Hilderbrand were present. The Pledge of Allegiance was said by all present. Commissioner Collins made a motion to approve the amended minutes for May 9, 2011 as submitted by Cherokee County Clerk Crystal Gatewood; his motion was seconded by Commissioner Hilderbrand with Commissioners Hilderbrand, Collins, and Garner voting in favor. Commissioners Hilderbrand, Collins and Garner, and County Clerk Gatewood signed off on the minutes.

Commissioners Collins, Hilderbrand, and Garner signed off on Voucher #2954 for Washington Electronics for \$5,878.00, the money would be paid out of the 911Wireless Account. The bill was submitted by Wayne Elliott, the Department Head of 911 Mapping. Commissioners Collins, Garner, and Hilderbrand signed off on employee position changes in the Cherokee County Treasurer's Office as submitted by County Treasurer Juanita Hodgson.

MOTIONS MADE BY COMMISSION

Commissioner Garner made a motion to recess for lunch; his motion was seconded by Commissioner Collins with Commissioners Collins, Garner, and Hilderbrand voting in favor.

EXECUTIVE SESSIONS

Commissioner Hilderbrand made the motion to go into **Executive Session for ten minutes for Personnel Issues** with himself and Commissioners Garner and Collins; his motion was seconded by Commissioner Collins with Commissioners Collins, Garner, and Hilderbrand voting in favor. They went in at 10:10 AM and returned at 10:20 AM.

At the request of Treasurer Juanita Hodgson for Executive Session, Commissioner Collins made a motion to go into Executive Session for Non-Elected Personnel for ten minutes with himself, Commissioners Garner and Hilderbrand, and County Treasurer Juanita Hodgson; his motion was seconded by Commissioner Hilderbrand with Commissioners Collins, Garner, and Hilderbrand voting in favor. They went in at 11:00 AM and returned at 11:08 AM.

OTHER BUSINESS

Leonard Vanatta, Road and Bridge Supervisor, and Gene Langerot of the County Lot discussed General County and road maintenance that was being done by his department. The Commission opened the bids the county received for tires, asphalt, fuel, lubricants, etc. Commissioner Collins made the motion to allow Gene Langerot and Leonard Vanatta of the County Lot to examine the bids and get back with the Commission after they have had time to review them more; his motion was seconded by Commissioner Hilderbrand; with Commissioners Collins, Garner, and Hilderbrand voting in favor. (A copy of all bids received is attached to these minutes and are also available in the Cherokee County Clerk's Office.)



County Treasurer Juanita Hodgson, Commissioners Collins, Garner and Hilderbrand, and County Counselor Kevin Cure discussed the upcoming Tax Sale via telephone. Cherokee County Treasurer Juanita Hodgson also stated that properties on the current Tax Sale can only be paid for in cash or with a cashier's check, and that personnel checks will not be accepted two weeks before the June sale.

Raymond Griffith came before the commission to discuss a land problem.

Betha Elliott, the Director of the County Health Department, and Representatives Tracie Lansing and Shelli Walrod of the Kansas Children Service League, came to discuss the outcomes of the program in Cherokee County. The program has a 98% success rate and Cherokee County has 16 families participating in the program, and more slots are available for families in Cherokee County. The Kansas Children Service League is working to provide services to families and aid in the prevention of child abuse and neglect for Kansas Children and their families. Commissioner Garner signed off on the new contract and the amended contract for County Services from the state of Kansas which goes into effect July 1, 2011. (A copy of the quarterly report for 2011 is attached to the minutes as provided by Shelli Walrod during the presentation to the commission.)

ADJOURNMENT

Commissioner Hilderbrand made a motion to adjourn the meeting at 1:48 PM; his motion was seconded by Commissioner Collins; with Commissioners Hilderbrand, Garner, and Collins voting in favor. The next Cherokee County Commission meeting will be held May 23, 2011 at 9:00 AM in the Cherokee County Courthouse in Columbus, Kansas.

The Cherokee County KCSL Healthy Families Program served 16 families in Cherokee County in the 1st quarter of 2011.

Of those 16 families, five (5) teen mothers.

75% of index children have documented up-to-date immunizations and well-baby checks.

28 referrals were given during the first to families for outside services, such as: food banks, medical providers, medical insurance, housing assistance, child care, etc.

Family Support workers handed out 72 pieces of curriculum to the 16 families in 1st Qtr.

Family Time Event was held on April 21st at the Baxter Springs Community Center. Ten (10) participating families attended, as did the Easter Bunny! The topic of education for this socialization event was being prepared in the event of Severe Weather. Families were given a Severe Weather Safety Plan to complete together. Families also worked with their children and made Easter Baskets and took pictures with the Easter Bunny. Dinner was served.

THEREFORE, the parties hereto agree to renew the original contract as referenced above as follows:

1. No Lapse for Successor to KHPA

Pursuant to Executive Reorganization Order No. 38, KHPA will become the Division of Health Care Finance, Kansas Department of Health and Environment effective July 1, 2011. This agreement, while executed before this effective date, will continue in effect. The successor can exercise any contractual authority granted to KHPA.

- 2. Purpose. To renew the contract for the first of two (2), optional one-year renewals, July 1, 2011 through June 30, 2012, and to set compensation for the renewal period.
 - **a.** Compensation: Total funding for the period July 1, 2011 through June 30, 2012 shall not exceed \$370,000.00, said amount comprising the Service Contractor matching funds of \$185,000.00 and the federal financial participation amount of \$185,000.00.


